Introduction

The new version published is in accordance with the international Berlin Group NextGenPSD2 standard, version 1.3. This version contains the feature related to the sub-resource consent and resource payment initiation.

Please note that the version in the URL will not change, the "v1" will be kept in all existing URL's.

Account Information Service - AIS

The following changes have been done for the AIS flow:

- Enable the support for "one-off" consent : the field recurringIndicator can also be used with the value **false**.

Endpoints

The below endpoint is affected:

- **POST /consents**

Payment Initiation Service - PIS

The following changes have been done for the PIS flow:

- Modification in structure of field "**creditorAddress**" in the payment request. Fields "city", "postalCode" and "street" are deprecated and will be removed in future release. The previous and new versions are as follows-
 - Previous version (will be deprecated in the next version)

- Correction has been done in "executionRule" for standing order. Updated value is **preceding** now which was earlier **preceeding** (both version are supported on this version).

Confirmation of Funds Service - PIIS

The following changes have been done for the **PIIS** flow:

- Support for version 2.0 of the international Berlin Group NextGenPSD2 standard (for compatibility, the value "**v1**" is kept).
 - Addition of new fields **cardExpiryDate**, **cardInformation** and **registrationInformation** in the resource "**consents/confirmation-of-funds**".
 - Deprecated support for field **validUntil** with new corresponding field **cardExpiryDate**: both can't be used.

Endpoints

The below endpoints are affected:

- **POST /consents/confirmation-of-funds**
- **GET /consents/confirmation-of-funds/{consentId}**

Signing Basket Service - SBM

The following changes have been done for the SBM flow:

- Support for SCA selection by PSU has been given (if several methods are available).

Endpoints

The below endpoint has been added:

- **PUT /signing-baskets/{basketId}/authorisations/{authorisationId}**

Signing Request with QSealC - AIS/PIS/PIIS/SBM

The structure of error message for the customer authorisation/authentication calls is now in accordance with the RFC 6750 and RFC 6749.
